#### **FIRST AMENDMENT TO ACC RULES**

## COMPLIANCE DEPOSIT AGREEMENT

THIS FIRST AMENDMENT TO THE ACC REVIEW REQUIREMENT, set forth in Attachment 16 to the Community Manual (this "Amendment") is as follows:

The Architectural Control Committee (the "ACC") has been established pursuant to the Declaration of Covenants, Conditions, Easements and Restrictions for The Dominion Planned Unit Development, recorded in Volume 2956, Page 0061, Bexar County, Texas, and any amendments thereto, or supplements or protective covenants filed in accordance therewith (collectively, the "Restrictions"). No improvement may be constructed on property subject to the Restrictions without the advance written approval of the ACC. The ACC Review Requirements set forth in Attachment 16 to the Community Manual outline the items required to be submitted to the ACC as a precondition to approval of a proposed improvement (the "ACC Review Package"). The ACC Review Package is hereby amended to include the following:

• Owner Compliance Deposit Agreement, if required by the ACC, at the ACC's sole discretion

#### Owner Compliance Deposit Agreement.

Prior to the commencement of any Improvement of Property within or subject to the Restrictions, the ACC may require that each Owner execute a Compliance Deposit Agreement (the "Agreement"), in a form approved by the ACC. Such Owner must comply with the terms of the Agreement including the submission of any compliance deposit which must be paid to the Association in conjunction with execution of the Agreement. Such compliance deposit under the Agreement will be in addition to Compliance Deposit required pursuant to the Owner Agreement set forth in Attachment 16 to the Community Manual. The compliance deposit under the Agreement is paid to the Association as security that construction of the proposed Improvements will commence and diligently be prosecuted to completion, as additional security against damage caused to the Association's common areas, streets, or other Property subject to the Declaration, and for other reasons set forth in the Agreement.

Terms used but not defined in this policy will have the meaning subscribed to such terms in that certain Declaration of Covenants; Conditions, Easements and Restrictions for The Dominion Planned Unit Development, recorded under Volume 2950, Page 61, in the Official Public Records of Bexar County, Texas, as amended and supplemented (collectively the "Declaration").
