NOTICE OF NON-UNIFORM ASSESSMENT

Bexar County, Texas

Cross Reference that certain Declaration of Covenants, Conditions, Easements and Restrictions for the Dominion Planned Unit Development, recorded as Volume 2956, Page 0061, Official Public Records of Bexar County, Texas as modified by that certain Declaration of Protective Covenants for C-2 Zoning, recorded as Volume 11085, Page 1060, Official Public Records of Bexar County, Texas, as amended by that certain First Amendment of Declaration of Projective Covenants for C-2 C Zoning, recorded as Volume 18343, Page 1468, Official Public Records of Bexar County, Texas.

Notice of Non-Uniform Assessment

This Notice of Non-Uniform Assessment (this "Notice") is made and executed on this 9 day of December 2016, by INTCO-DOMINION PARTNERSHIP, a Texas general partnership ("Declarant") and agreed to and consented to by The Dominion Homeowners Association, Inc., a Texas non-profit corporation (the "Association"), and is as follows:

RECITALS

1. Authority Under Umbrella Declaration. Pursuant to Article III, Section 10 of the Declaration of Covenants, Conditions, Easements and Restrictions for The Dominion Planned Unit Development dated October 18, 1983, and recorded in Volume 2956, Page 61, of the Official Public Records of Real Property of Bexar County, Texas, as amended (the "Umbrella Declaration"), Declarant may, in its sole discretion, elect to modify the assessments imposed on non-residential property on a non-uniform basis by filing a Notice of Non-Uniform Assessment.

2. Designation of Non-Uniform Assessment. This Notice of Designation of Non-Uniform Assessment is filed with respect to Lot 1, Block 14, NCB 34753A, The Dominion Phase 1-B, Planned Unit Development, an addition to the City of San Antonio, Bexar County, Texas, according to the map or plat thereof recorded in Volume 9508, Page 21, Deed Records of Bexar County, Texas (the "Tract"). Assessments will be levied against the Tract in increments known as a "Non-Uniform Commercial Assessment". The Non-Uniform Commercial Assessment will be levied against the Tract in an amount equivalent to One Thousand and Eighty-Three Dollars (\$1,083.00) per month.

3. Adjustment to Non-Uniform Commercial Assessments. Beginning on January 1, 2017, and continuing annually each year thereafter, the Non-Uniform Commercial Assessment shall be increased by the greater of:

(i) the percentage of increase, if any, in the cost of living index at the beginning of January 1, 2017 and each calendar year thereafter, over and above the cost of living index at the commencement of the immediately preceding calendar year. For purposes of this Paragraph 3(i), increases in the cost of living index shall be measured by the Consumer Price Index for "All Urban Consumers, U.S. City Average, All Items," issued by the Bureau of Labor Statistics of the United States Department of Labor. The figures for purposes of calculating the percentage increase, if any, shall be the last figures published prior to the applicable measurement date. If for any reason the Bureau of Labor Statistics does not furnish such an index and such information, the Board of Directors of the Association may use such other index or comparable statistics on the cost of living for Bexar County, Texas, as shall be computed and published by an agency of the United States or by a responsible financial periodical of recognized authority;

OR

(ii) the percentage of increase, if any, in the uniform regular monthly assessment to be levied by the Board of Directors of the Association for residential lots subject to the Umbrella Declaration for the calendar year 2017 and each calendar year thereafter, over and above the uniform regular monthly assessment levied by the Board of Directors of the Association during the immediately preceding calendar year.

4. Subdivision. In the event the Tract is subdivided into additional platted lots, each resulting lot will be allocated a Non-Uniform Commercial Assessment.

5. Miscellaneous. This notice constitutes a notice of non-uniform assessment under Article III, Section 10 the Umbrella Declaration. Any capitalized terms used and not otherwise defined in this notice shall have the meanings set forth in the Umbrella Declaration.

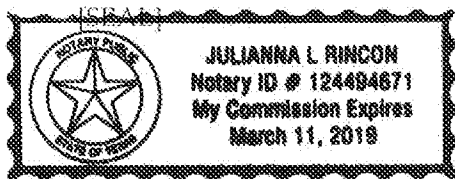

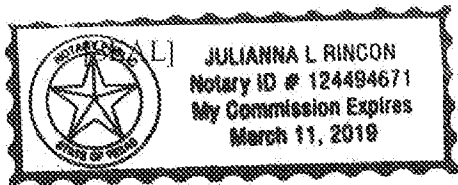
