# THE DOMINION HOMEOWNERS ASSOCIATION POND USE RESTRICTIONS

#### USE OF COMMUNITY PONDS, LAKES, TANKS, AND WATER FEATURES

Terms used but not defined in these restrictions will have the meaning subscribed to such terms in that certain <u>Declaration of Covenants</u>, <u>Conditions</u>, <u>Easements and Restrictions for The Dominion Planned Unit Development</u>, recorded under Volume 2956, Page 61, in the Official Public Records of Bexar County, Texas, as amended and supplemented (collectively the "Declaration").

- 1. <u>Recreational Use Prohibited.</u> The Dominion community contains several ponds, lakes, tanks and/or water features (collectively, the "Ponds"), that serve various aesthetic and functional purposes. The Ponds are maintained by the Association for the enjoyment of Owners, Residents and their invited guest(s). The Ponds are subject to the following restrictions:
  - a. <u>No Swimming</u>. Swimming, wading, bathing, and entry into any Pond, for any reason, are prohibited.
  - b. <u>No Boating or Watercraft</u>. Boating or use of any boating or flotation device on any Pond is prohibited. This prohibition includes boating of any type (whether propelled by a motor, paddle, or oars), canoeing, kayaking, rafting, tubing, floating, or any other method of flotation or transportation across a body of water.
  - c. Golf Carts. Golf carts on Pond walkways are prohibited.
  - d. Fishing. Fishing in any Pond is prohibited.
  - e. <u>Fish, Animals and/or Plant Life</u>. The release of any fish, animals and/or plant life into any Pond is prohibited.
  - f. Pets. Pets are prohibited from entry into any Pond.
  - g. <u>Children</u>. Children sixteen (16) years of age and under must be accompanied by an adult Owner, Resident or authorized guardian who is (18) years of age or older when in any Pond area.
  - h. <u>USE OF ANY POND, POND AREA AND/OR POND WALKWAY IS AT THE DISCRETION OF OWNERS, RESIDENTS AND THEIR INVITED GUEST(S) AND/OR AUTHORIZED GUARDIAN(S). PLEASE USE CAUTION, USE AT YOUR OWN RISK.</u>
