THE DOMINION HOMEOWNERS ASSOCIATION

AMENDED AND RESTATED CONTEMPORARY AND MODERN HOME POLICY

Terms used but not defined in this policy will have the meaning subscribed to such terms in that certain <u>Declaration of Covenants</u>, <u>Conditions</u>, <u>Easements and Restrictions for The Dominion Planned Unit Development</u>, recorded under Volume 2956, Page 61, in the Official Public Records of Bexar County, Texas, as amended and supplemented (collectively the "**Declaration**").

This Amended and Restated Contemporary and Modern Home Policy (the "Contemporary and Modern Home Policy"), identifies the neighborhoods/subdivisions within The Dominion which are suitable for homes with contemporary and/or modern architectural styles. The Dominion is a community comprised of custom homes with a variety of architectural styles such as, but not limited to, traditional, transitional, contemporary and modern.

The Architectural Control Committee (ACC) is charged with reviewing and approving plans for new homes in The Dominion and maintaining harmonious architecture within the various neighborhoods/subdivisions of The Dominion. The ACC has deemed contemporary and modern architectural styles not harmonious in established neighborhoods/subdivisions which contain mostly traditional and/or transitional architectural styles or architectural styles other than contemporary and/or modern.

This Contemporary and Modern Home Policy designates the following neighborhoods/subdivisions as conducive to homes with contemporary and/or modern architectural styles:

- 1. Hilltops at The Dominion, Phase 1;
- 2. The Bluff at The Dominion;
- 3. Avila at The Dominion;
- 4. Alturas at The Dominion;
- 5. Aragon at The Dominion;
- Vineyard Estates at The Dominion; and
- 7. Renaissance IV at The Dominion.

Owners and Homebuilders who want to build homes with contemporary and/or modern architectural styles are encouraged to build such homes only in the neighborhoods/subdivisions listed hereinabove.

Owners and Homebuilders who want to build homes with contemporary and/or modern architectural styles in neighborhoods/subdivisions other than those listed hereinabove shall be required by the ACC to modify their architectural plans to build a home with a traditional and/or transitional architectural style.

To the extent possible, the ACC will endeavor to inform persons interested in building homes with contemporary and/or modern architectural styles in The Dominion of this Contemporary and Modern Home Policy prior to the purchase of a Lot and/or plan to build a home in The Dominion. In order to do so, The Dominion Homeowners Association and the ACC will (i) inform known Homebuilders and realtors who provide service in The Dominion of this Contemporary and Modern Home Policy; (ii) will include the provisions of this Contemporary and Modern Home Policy in resale certificate packages; and (iii) will post this Contemporary and Modern Home Policy on The Dominion website.
