Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Umbrella Restrictions and the Special Assessment and all other terms and provisions of the Umbrella Restrictions and the Special Assessment remain in full force and effect as written, and are hereby ratified and confirmed.
