# **ASSIGNMENT OF DECLARANT RIGHTS**

Assignor, for and in consideration of the sum of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNS and TRANSFERS to Assignee all of its rights, titles and interests as Declarant as set forth in that certain Declaration of Covenants, Conditions, Easements and Restrictions for The Dominion Planned Unit Development, originally executed by Dominion Group, Inc. as Declarant on October 18, 1983 ("Declaration"), and recorded on November 1, 1983 in Volume 2956, Page 61, of the Official Public Records of Real Property of Bexar County, Texas, and in all Certificates of Annexation, Declarations of Protective Covenants and all other related documents, including, but not limited to, those set forth in Exhibit "A", attached hereto and incorporated herein by reference, which have previously been assigned to Assignor by that certain Assignment of Rights as Declarant dated November 30, 1989 and executed by FCC Holdings, Inc. and recorded in Volume 4727, Page 518 of the Official Public Records of Real Property of Bexar County, Texas, and which were previously assigned to FCC Holdings, Inc. by that certain other Assignment of Rights as Declarant dated September 25, 1987 and executed by Dominion Group, Ltd. and recorded in Volume 4145, Page 2082 of the Official Public Records of Real Property of Bexar County, Texas.

This Assignment is made on the following terms, covenants and conditions:

- 1. Assignee may exercise all rights and will assume all obligations of the Declarant under the Declaration and related documents and Assignee shall be deemed to be the Declarant under the Declaration and related documents from and after the date of this Assignment. Assignor hereby relinquishes all claims and rights as Declarant from and after the date of this Assignment.
- 2. Assignee agrees to assume the obligations previously undertaken by Assignor in paragraph 2 of the above-described prior Assignment of Rights as Declarant from FCC Holdings, Inc., and the obligations previously undertaken by FCC Holdings, Inc. in paragraph 2 of the above-described prior Assignment of Rights as Declarant from Dominion Group, Ltd.
- 3. As expressly provided by Article III, Section 7, of the Declaration, and due to the conveyance to Assignee of all of Assignor's properties which are subject to the Declaration simultaneously with the execution hereof, no assessments shall commence as a result of such conveyance, this assignment or any of the transactions contemplated thereby or hereby.
- 4. This Assignment shall be recorded in the Official Public Records of Real Property of Bexar County, Texas.



5. This Assignment, together with the covenants and warranties herein contained, shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor, its successors and assigns.


